Position: **Co-founder and President of the Board**

Responsibilities: Co-founded this non-profit ministry and work daily to end human trafficking in the United States through awareness, prevention, combating demand, rescuing victims, and influencing government policy and providing safe refuge for the restoration of survivors. In July of 2017 helped open the first trafficked boy's safe home in all of the country. The U.S.I.A.H.T. is addressing this national problem and doing so with on-the-ground community based services.

The U.S.I.A.H.T. focus on the prevention of human trafficking in the United States is being accomplished through combating demand in new and innovative ways, raising awareness, educating our youth, disruption of trafficking activities, advocating a consolidation within the industry to maximize efficiencies, and collaborating with organizations who are expert at rescuing abducted youth currently engaged in the sex trade. Our work is also done in conjunction with federal, state and local government officials who sit in a position to influence policy on ending trafficking in America.
